**YAVATMAL 30 Sept (District Correspondent):** Due to heavy rains, farmers in Yavatmal district have suffered heavy losses. Farmers need to be compensated as the crop insurance amount has been paid. Therefore, the affected farmers should be compensated for crop insurance immediately; otherwise we will have no choice but to take to the streets, warned MP Bhavnatai Gawali. Yavatmal district received mild rains in June this year. After that, in the months of July, August and September, it continues to rain. Now that the time for

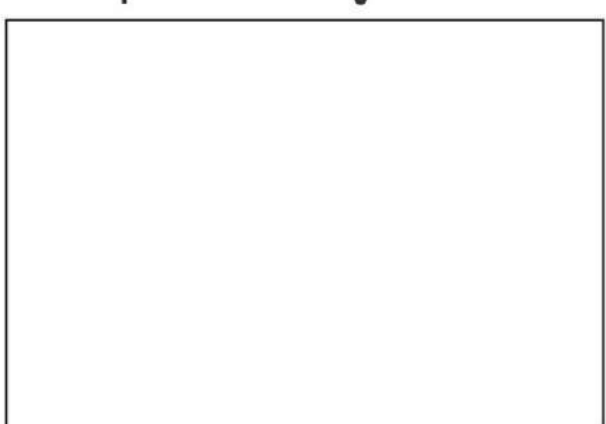

## 58 percent kharif loans provided to farmers

**Amravati 30 September (District Correspondent):** This year's kharif crop loan disbursement has been 58 percent as loan disbursement of Rs 1004.84 crore against target of Rs 1,720 crore has been made in the district. This is the highest rate in the last five years. The Mahatma Jyotirao Fule Shetkari Karjukt Yojana is also being effectively implemented to facilitate distribution of kharif loans to distressed farmers. Under Mahatma Jyotirao Fule Shetkari Karjukt Yojana, 1,09,776 account-holders have been given benefit of about Rs 793.91 crore. The crop loan distribution target for this year's kharif season is Rs 1,720 crore.
