Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that the Mining Lease deed dated 03<sup>rd</sup> May, 2007 and 03<sup>rd</sup> December, 2021 of the Company in respect of Iron Ore mining area of 348.09 Ha valid up to 02<sup>nd</sup> May, 2057 i.e., for 50 years had some clauses which restricted the sale of Iron Ore beyond Maharashtra by the Company.

Government of Maharashtra vide Order No. MMN-1004/CR-683/Ind-9 dated 25<sup>th</sup> April, 2022 held the said restrictive clauses as void and directed the Director of Geology and Mining, Nagpur to delete the said restrictive clause from the Mining Lease deed dated 03<sup>rd</sup> May, 2007 and 03<sup>rd</sup> December, 2021.

In pursuance to the above order, Supplement to Lease Deeds dated 03<sup>rd</sup> May, 2007 and 03<sup>rd</sup> December, 2021 was executed between Government of Maharashtra and Lloyds Metals and Energy Limited on 13<sup>th</sup> May, 2022.
